Description:

The Emergency Services Elective rotation is a 1-month elective training period for residents at North Mississippi Medical Center to provide an experience that utilizes pharmacy clinical services in the emergency services department (ESD). North Mississippi Medical Center is a level-II trauma center. The emergency department features 58 patient rooms that staffed by a variety of licensed professionals (e.g., physicians, emergency medicine fellows, physician assistants, and nurse practioners). This rotation allows the resident to participate in the essential roles of an ESD pharmacist. During this rotation, residents will interact with patients and other health care practitioners to optimize the medication use process, and perform the following essential functions of an ESD pharmacist; order review, drug therapy monitoring, participation in high-risk procedures including resuscitation efforts, monitor high-risk medications, medication procurement and preparation, and provide drug information. The resident will become part of the health care team whose goal is the well-being and successful clinical management of the problems and diseases of patients.

Expectation of Learners:

Topic discussions and reading key articles will be used to help develop the resident's patient care skills for common diseases and/or disease states infrequently seen on the service.

During the learning experience, the resident will focus on the goals and objectives outlined below by performing the activities that are associated with each objective. The resident will gradually assume responsibility for all patients within the ESD. Of note, the length of time the preceptor spends in each of the phases is dependent upon the resident's abilities and the timing of the learning experience within the residency year.

Prior to rotation (Direct Instruction): Resident is required to setup an orientation meeting. During which, the resident will be given educational materials to review prior to the start of the rotation. The preceptor will review the learning experience description to ensure residents understand the goals of the rotation.

Week 1 (Modeling): The resident is expected to work up patient located in Zone A and to present to the preceptor daily. Preceptor to attend and participate in patient care with the resident, modeling the pharmacist's role on the team.

Week 2 (Coaching): The resident is expected to work up patient located in Zone A and B and to present to the preceptor daily. Preceptor to attend and coach the resident to take on more responsibilities of the pharmacist on the team.

Week 3+ (Facilitating): The resident is expected to take on more responsibilities of working up more the team's patients, continuing to discuss with the preceptor on a daily basis. When the resident demonstrates responsibility for taking care of the patient the preceptor will no longer attend rounds but will continue to facilitate the residents learning.
